NOTICE TO ALL KNOWN AFFECTED PERSONS OF GROUP FIVE CONSTRUCTION (PROPRIETARY) LIMITED (the "Company") REGARDING THE TERMINATION OF THE BUSINESS RESCUE PROCEEDINGS OF THE COMPANY

In accordance with Section 132(2)(c)(ii) of the Companies Act 71 of 2008 ("**the Act**") you are hereby notified of the following:

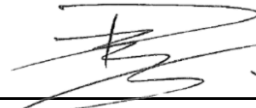
1. Capitalised words not otherwise defined in this report shall have the meaning ascribed to them in the approved Business Rescue Plan for the Company as published on 30 August 2019 (the "**BR Plan**").
2. The BR Plan has been substantially implemented as per the definition in the BR Plan.
3. All known, traceable and verified Creditors have been paid in full and in accordance with the provisions of the BR Plan. Cash provision has been made for the settlement of reasonably estimated future claims by currently untraceable or unverified Creditors and/or contingent Creditors.
4. As a result, and in accordance with Section 152(8) of the Act, as read with section 132(2)(c)(ii) of the Act, the Business Rescue Proceedings of the Company have been formally terminated, effective **30 June 2026** (the "**Termination Date**").
5. It is the business rescue practitioners' view that, over and above the full and final settlement of Creditors noted in paragraph 3 above, the Company may, over time, also be in a position to provide a positive return to its shareholder (that being Group Five Limited ("**Group Five**")).
6. It is noted that the duly adopted business rescue plan for Group Five has been substantially implemented and the business rescue proceedings of Group Five have similarly been formally terminated, effective 30 June 2026.
7. Control of the Company, with effect from the Termination Date, has been handed over to an interim Board of Directors (the "**Board**") that has been duly appointed. The Board will oversee all financial and administrative matters which remain unresolved as at the Termination Date. It is the intention of the Board to appoint a new independent non- executive director to serve alongside the current members of the Board.

8. A copy of the Form COR125.3 (Notice of Termination of Business Rescue Proceedings) has been filed with the Companies and Intellectual Property Commission and is available for download on the Company's website at:

9. Concurrent Creditors, including trade creditors and sub-contractors, that have not yet received any or all of the cash distributions they believe are due to them are advised to contact Nesh Singh on email nsingh@groupfive.co.za with details of such claims so that due payments may be released. Payments will only be made to recognised and appraised Concurrent Creditors as previously notified in accordance with the business rescue proceedings of the Company and the approved BR Plan for the Company. The purpose of such contact will be to validate information including: the validity of the claim so submitted; bank details; and the identification of the submitter/claimant.
