NOTICE TO THE AFFECTED PERSONS OF THE COMMENCEMENT OF BUSINESS RESCUE PROCEEDINGS IN RESPECT OF GROUP FIVE CONSTRUCTION PROPRIETARY LIMITED (IN BUSINESS RESCUE) ("THE COMPANY") IN TERMS OF SECTION 129(3)(a) OF THE COMPANIES ACT 71 OF 2008

- 1 You are hereby notified that the board of the Company adopted a resolution on 11 March 2019 in accordance with Section 129(1) of the Companies Act 71 of 2008 (as amended) ("the Companies Act") in terms of which the Company voluntarily commenced business rescue proceedings.
- 2 A form CoR 123.1, being a Notice of Beginning of Business Rescue, as contemplated in section 129(2)(b) of the Companies Act, and Regulation 123 of the Companies Regulations of 2011 together with a sworn statement, was filed with the Companies and Intellectual Property Commission ("the Commission") on 11 March 2019.
- 3 The effective date of the Company's business rescue proceedings is accordingly 11 March 2019.
- 4 In accordance with the requirements of Section 129(3)(a) of the Companies Act, please find herewith:
 - 4.1 the notice to commence business rescue proceedings (form CoR 123.1), filed with the Commission;
 - 4.2 the resolution passed by the board of directors of the Company; and
 - 4.3 a sworn statement of the facts relevant to the grounds on which the board resolution was founded.
- 5 When the board of the Company adopted a resolution on 11 March 2019 in accordance with Section 129(1) of the Companies Act 71 of 2008 (as amended) ("the Companies Act") for the Company to voluntarily commence business rescue proceedings, it also resolved to appoint Mr Dave Lake and Mr Peter van den Steen as joint business rescue practitioners. Both business rescue practitioners accepted this appointment.
- 6 Accordingly, a form CoR 123.2, being a Notice of Appointment of Business Rescue Practitioners, as contemplated in section 129(4)(a) of the Companies Act, and Regulation 123 of the Companies Regulations of 2011, was filed with the Companies and Intellectual Property Commission ("the Commission") on 13 March 2019.

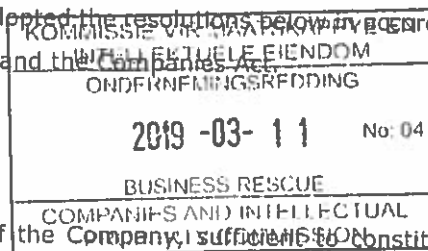

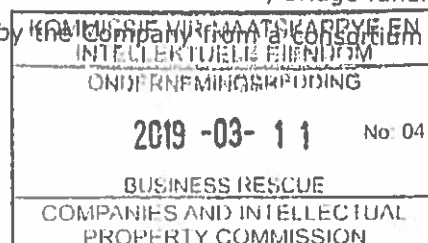
- 1 Adequate notice of the meeting and the agenda was given to the directors of the Company in accordance with Article 26.4.3.1 of the Memorandum of Incorporation ("MOI"), as read with section 73 of the Companies Act 71 of 2008, as amended ("Companies Act");
- 2 A quorum was present for the meeting in person and/or via electronic communication, and that all time periods for the convening of this board meeting as required in terms of Article 26.5 of the MOI and otherwise are hereby waived and/or condoned, to the extent necessary, given the urgency of the agenda items;
- 3 After careful consideration, the directors adopted the resolutions below in accordance with the provisions of the Company's MOI and the Companies Act.

WHEREAS –

- 4 The members of the board of directors of the Company, sufficient to constitute a quorum and validly consider and resolve on such matters, reasonably believe that the Company is financially distressed, within the meaning of Section 128(1)(f)(ii) and 129(1)(a) of the Companies Act as it reasonably appears that the Company's liabilities currently exceed its assets. In addition the company is financially distressed within the meaning of section 128(1)(f)(i), as it will be unable to pay its debts as they become due and payable within the ensuing 6 months, for the following reasons:



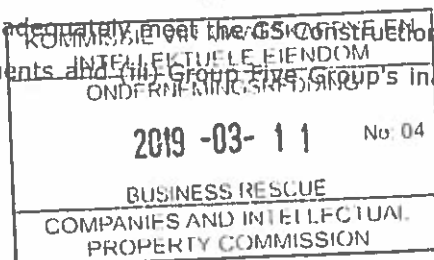
- 4.1 The Company commenced business in the 1970's and has conducted business in the construction industry.
- 4.2 The Company is a wholly owned subsidiary of Group Five Limited (Registration Number 1969/000032/06) ("Holdco"). Holdco has a number of direct and indirect subsidiaries in addition to the Company (collectively the "Group Five Group").
- 4.3 The Company has a number of direct and indirect subsidiaries ("G5 Construction Group"), including wholly owned subsidiary Group Five power International Proprietary Limited (Registration number 2008/007984/07)("G5PI");
- 4.4 G5PI entered into a written contract with Cenpower Generation Company Limited (the "Client") for the design, engineering, procurement, construction, commissioning and testing of the 350MW gas and oil fired combined cycle power plant at Kpone in the Republic of Ghana (the "Project") (the "Kpone Construction Contract");
- 4.5 The Project resulted a loss for G5PI. The inadequate balance sheet and income generating capacities of G5PI resulted in its dependency on cash resources from the G5 Construction Group to meet its obligations in respect of the Kpone Construction Contract;
- 4.6 The G5 Construction Group reflected an operating loss before tax of approximately R 1.23 billion for the year end June 2018, which compares negatively to the budget of R 224 million profit before tax.
- 4.7 The G5 Construction Group experienced negative cash flows from operating activities of R 880 million for 2018.
- 4.8 Market conditions in the construction industry have worsened, and certain of the Company's projects were under-priced which resulted in these projects being loss-making.
- 4.9 In order to alleviate the cash flow constraints of the G5 Construction Group brought about by virtue of the circumstances described above, bridge funding in the sum of R650 million was sought by the Company from a consortium of

lenders (the "Lending Consortium") and was granted to the Company in April 2018 (the "Bridge Funding Facilities").

- 4.10 As an element of the provision of the Bridge Funding Facilities, Holdco and a number of other companies within the Group Five Group (including companies in the G5 Construction Group), guaranteed to the Lending Consortium, the payment and other obligations (collectively the "Debt Obligations") of (i) the Company to the Lending Consortium under or in relation to the Bridge Funding Facilities and (ii) various members of the Group Five Group to individual members of the Lending Consortium in respect of various other extant banking, guarantee and like facilities provided from time to time by such individual members of the Lending Consortium to such members of the Group Five Group.
- 4.11 The Company's financial constraints were exacerbated, on or about on 30 November 2018, following the termination of the Kpone Construction Contract, when payment of US\$106,5 million was demanded by the Client from the guarantee providers under the guarantees that were issued in respect of the Project. In the result, the Company became indebted to such guarantee providers under counter-Indemnity arrangements, which came into force when payment in respect of such guarantees was made by the guarantee providers. Such indebtedness has not been repaid as at the date hereof.
- 4.12 The G5 Construction Group is currently conducting retrenchment proceedings and it is estimated that severance pay in the sum of R 233 million will become payable to retrenched employees pursuant thereto.
- 4.13 On 22 February 2019 the Company sought additional bridge funding from the Lending Consortium in the sum of R350 million for the G5 Construction Group's immediate short term working capital requirements. Whilst the Company's management and board of directors at the time believed that there was a reasonable prospect of such bridge funding being provided, on 4 March 2019 the Lending Consortium formally advised the Company that its request for such funding could not be accommodated, *inter alia* given (i) the sums of money and/or guarantee facilities already provided by the Lending Consortium and/or its individual members to the Group Five Group, (ii) the lack of certainty that any further funds provided would adequately meet the G5 Construction Group's ongoing working capital requirements and (iii) Group Five Group's inadequate

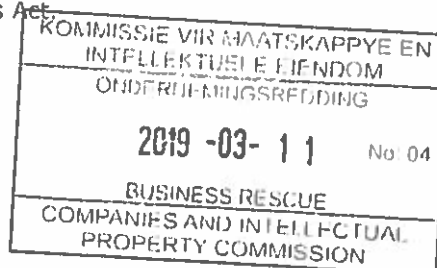
balance sheet capabilities and income generating capabilities to successfully service and repay existing debt and any further debt to be incurred.

4.14 The cash flow forecast for the 2019 financial year, indicates that the G5 Construction Group will have a cash shortfall of approximately R 2.39 billion.

5 Based on representations made by the Company's management, the board of directors of the Company believe that there is a reasonable prospect of rescuing the Company in terms of Section 129(1)(b) of the Companies Act.

ACCORDINGLY, IT IS RESOLVED THAT -

- 1 the Company voluntarily commences with business rescue proceedings immediately and that it be placed under supervision in terms of Section 129(1) of the Companies Act;
- 2 the Company forthwith lodge the requisite documents for the commencement of business rescue proceedings with the Companies and Intellectual Property Commission of South Africa and any documents ancillary thereto and/or necessary for the commencement and/or continuation of business rescue proceedings;
- 3 Dave Lake (ID Number: 580704 5324 186), and Peter Van Den Steen (ID Number: 681107 5024 087), turnaround specialists, be appointed as the joint business rescue practitioners as contemplated in section 129(3)(b) of the Companies Act;
- 4 to the extent required, authorise Werksmans Attorneys of 96 Rivonia Road, Dennehof, Sandton to lodge any and all documents with the Companies and Intellectual Property Commission in order to give effect to the aforesaid resolutions;
- 5 THABO CLIFORD KGOGO (ID Number: 760414 5827 087) in his capacity as director of the Company or ANTHONY JOHN CLACHER (ID Number: 65011 65192 080) in his capacity as the director of the Company be and is hereby authorised to do all things necessary, or to procure the doing of all things necessary, and to sign any and all documents, or to procure the signing of any and all documents, as is necessary to give effect to the resolutions aforesaid on behalf of the Board of Directors of the Company, including deposing and signing the sworn statement contemplated in section 129(3)(a) of the Companies Act.

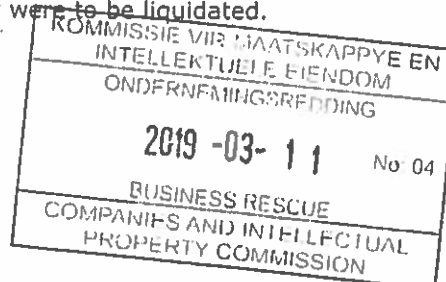

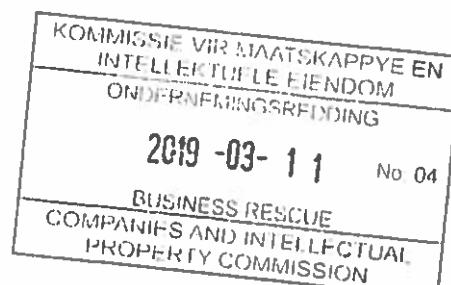
- 1 I am a director of Group Five Construction Proprietary Limited (Registration Number: 1974/003166/07) ("Company"), a company with its registered address and principal place of business at 2 Eglin Road, Sunninghill, Sandton, 2191.
- 2 I am duly authorised to depose to this sworn statement on behalf of the Company.
- 3 The facts contained herein were presented to the Company's board of directors by Dr THABO KGOGO, as a director the Company's board, at an urgent special meeting of the Company's board of directors on 11 March 2019, and which I believe to be true and correct.
- 4 This Sworn Statement is made by me on behalf of the Company to support the commencement of business rescue proceedings ("Business Rescue") in terms of Section 129 of the Companies Act, 2008 ("Act").
- 5 With this Sworn Statement, I intend to provide the relevant information that is required in order to demonstrate that the Company should be placed in Business Rescue.
- 6 The information contained in this Sworn Statement and the opinions expressed in the Sworn Statement relate to the financial difficulties of the Company and how the Company can –
 - 6.1 be rescued and continue as a going concern as an alternative to liquidation; or
 - 6.2 pay a higher dividend to its creditors than that which would become payable to creditors if the Company were to be liquidated.

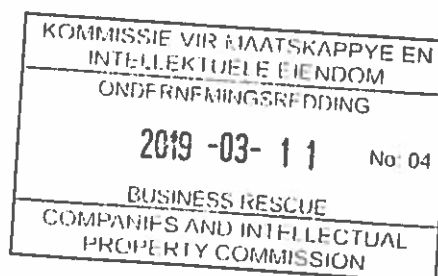
FINANCIAL DISTRESS:

- 7 The Company commenced business in the 1970's in the construction industry.
- 8 The Company is a wholly owned subsidiary of Group Five Limited (Registration Number 1969/000032/06) ("Holdco"). Holdco has a number of direct and indirect subsidiaries in addition to the Company (collectively the "Group Five Group").
- 9 The Company has itself, a number of direct and indirect subsidiaries ("G5 Construction Group"), including wholly owned subsidiary Group Five power International Proprietary Limited (Registration number 2008/007984/07)("G5PI");
- 10 G5PI entered into a written contract with Cenpower Generation Company Limited (the "Client") for the design, engineering, procurement, construction, commissioning and testing of the 350MW gas and oil fired combined cycle power plant at Kpone in the Republic of Ghana (the "Project") (the "Kpone Construction Contract");
- 11 The Project resulted a loss for G5PI. The inadequate balance sheet and income generating capacities of G5PI resulted in its dependency on cash resources from the G5 Construction Group to meet its obligations in respect of the Kpone Construction Contract;
- 12 The G5 Construction Group reflected an operating loss before tax of approximately R 1.23 billion for the year ended June 2018, which compares negatively to the budget of R 224 million profit before tax for the same period.
- 13 The G5 Construction Group experienced negative cash flows from operating activities of R 880 million for 2018.

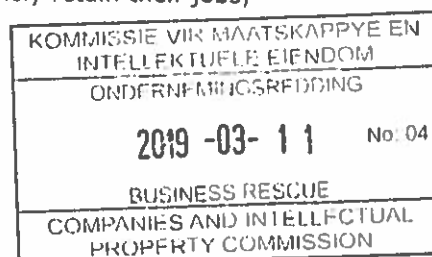
- 16 As an element of the provision of the Bridge Funding Facilities, Holdco and a number of other companies within the Group Five Group (including companies in the G5 Construction Group), guaranteed to the Lending Consortium, the payment and other obligations (collectively the "Debt Obligations") of (i) the Company to the Lending Consortium under or in relation to the Bridge Funding Facilities and (ii) various members of the Group Five Group to individual members of the Lending Consortium in respect of various other extant banking, guarantee and like facilities provided from time to time by such individual members of the Lending Consortium to such members of the Group Five Group.
- 17 The Company's financial constraints were exacerbated, on or about on 30 November 2018, following the termination of the Kpone Construction Contract, when payment of US\$106,5 million was demanded by the Client from the guarantee providers under the guarantees that were issued in respect of the Project. - 20 The G5 Construction Group's cash flow forecast for the 2019 financial year, indicates that the G5 Construction Group will have a cash shortfall of approximately R 2.39 billion.
- 21 The Company is financially distressed, within the meaning of Section 128 of Chapter 6 of the Act, in that, *inter alia* –
- 21.1 it is estimated that the Company, under current market conditions, requires an amount of R3.6 billion to fund its (and by implication, the G5 Construction Group's working capital requirements up to December 2019, including the repayment of the Bridge Funding Facilities and the payment of severance pay payable in relation to the aforementioned retrenchment proceedings. The Company is not able to itself generate such working capital, nor is it able to raise such working capital from other Group Five Group companies and/or third parties, given the weakness of its balance sheet. Based on past experience it has also become clear that Holdco's shareholders are unable or unwilling to provide any such working capital in the immediate future for the benefit of the Group Five Group; and
- 21.2 it therefore appears to be reasonably unlikely that the company will be able to pay all of its debts as they fall due and payable within the immediately ensuing six months (in terms of section 128(1)(f)(i) of the Companies Act 2008 (the "Act")).

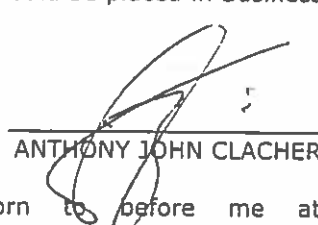
REASONABLE PROSPECT OF RESCUE

- 22 Notwithstanding the above, the directors of the Company believe that there is a reasonable prospect of rescuing the business of the Company, if action is taken immediately and if the Company commences Business Rescue. If the Company is placed under supervision, initiatives can be taken by a business rescue practitioners, when duly appointed, to take the following steps -
- 22.1 imposing an immediate temporary moratorium on all payments to creditors in terms of section 133 of the Act;
- 22.2 negotiating the sale of the Company's business as a going concern or of its assets, or the shares held in the Company to potential purchasers, at a value higher than would be achieved in a liquidation and where the majority of employees of the company would most likely retain their jobs;

- 22.3 considering the possible suspension or cancellation of various contracts in terms of section 136(2) of the Act;
- 22.4 continuous engagement with stakeholders to retain value in the Company and its assets (including without limitation its subsidiaries);
- 22.5 a restructure of the debt of the Company with its creditors; and
- 22.6 engaging in discussions with various parties regarding the provision of post commencement financing to the Company.
- 23 Accordingly, the Company through its board of directors, is of the view that the company is financially distressed, but that there remains a reasonable prospect of rescuing the company and accordingly that the Company should be placed in Business Rescue.
